

ACT NOW TO LEGALIZE MARIJUANA IN CALIFORNIA: TELL THE LEGISLATURE TO SUPPORT AB 390 *The Marijuana Control, Regulation and Education Act* by Assemblyman Tom Ammiano

The California Assembly will be hearing Tom Ammiano's landmark bill to legalize, tax and regulate marijuana in early January, 2010. Please tell your Assembly member that it's time to stop wasting money on marijuana prohibition and to reap the benefits of a legally regulated market. Tell them AB 390 would save taxpayer dollars and generate tax revenues; cut marijuana crime; protect the environment from pirate growers; and put violent traffickers out of business.

AB 390 would:

- *Legalize marijuana use and possession for all adults age 21;*
- *License, tax & regulate commercial sales & production of marijuana like alcohol;*
- *Generate an estimated \$1.4 billion in revenues by: (1) reducing enforcement costs and (2) imposing a \$50/ounce excise tax on commercial non-medical marijuana (the cost of which to consumers would be more than offset by the much reduced costs of legal production);*
- *NOT Change existing medical marijuana laws;*
- *Allow personal use cultivation of up to six plants.*
