

DV-101 additional Description of Abuse

12 On 4/21/2007 I have had enough of the terrorist threats, fear, and intimidation being directed
13 and used conveyed to me by BERNARD JAMES TYSON SR who is the RESPONDENT. I believe
14 RESPONDENT will carry out all of his conveyed threats and continue to at in the manner in which
15 I am now describing if given the any further opportunity.

16 This is a detailed account of the entire ordeal as to what took place at my house on 4/21/2007
17 and the history of other events relating to abuse by the RESPONDENT .

18 RESPONDENT is very cunning whenever the children or anyone else is present or in ear
19 shot, as RESPONDENT is extremely careful that he is not seen or heard acting in the vile,
20 sadistic, and wantonly disrespectful manner he acts in my presence. On 4/21/2007 I wanted to
21 contact the police however fearing the JUDGE may shun me, and so as not to disrupt the childrens
22 lives I continued to endure being abused by RESPONDENT. Even after I filed for divorce I still have
23 been abused and threatened and taken allot of unnecessary abuse that I should not have to be
24 subjected to. Although I expect reprisal in many forms, I am taking a stance here and now.

25 On 4/21/2007 at or about 3:54pm RESPONDENT boldly walks right in to my home
26 unannounced and uninvited! He walks towards me and acts as if he was going to slap me, causing
27 me to jump back to a defensive position, then he raises his hands towards his hair and rubs back on
28 it saying "*if i wanted to slap you, you'd be picking yourself up off the floor*".

1 RESPONDENT then indicates he has something for me and pulls out his rubber penis (his
2 old sex toy) or "DILDO". He said " *Here carla you could have this now that I don't need it*
3 *anymore. Hurricane is all the man I need and can satisfy me better then you ever could as my*
4 *wife...*" He then threw the dildo at me and as a natural reaction caught what was being thrown at me.
5 I then went to the kitchen and put it in a bag. **BRIEF HISTORY** about his male sex partner
6 HURRICANE and the significance of the dildo thrown at me. Hurricane is/was the name of
7 RESPONDENT'S male sex partner who RESPONDENT would regularly ask me to join in on with
8 him on. I would always say no and RESPONDENT would say just watch at least so you can learn
9 how to take it like I do. I would say no and recall getting sick to my stomach. When I would cry
10 about it he would leave me alone.

11 The last traumatic event involving the Dildo was in 2004 when RESPONDENT got upset
12 at me for not wanting to engage in a oragy with him and hurricane and after hurricane left
13 RESPONDENT slapped me across my face with the dildo and then raped me with it.
14 RESPONDENT knows very well the emotion stress and significance behind his Dildo he threw at
15 me on 4/21/2007 and did it to cause me emotional stress behind. I always felt bad for not
16 calling the police on RESPONDENT and feared If I told on him he would get me. Coincidentally the
17 abuse incident with the Dildo was one of the many reasons I filed for Divorce. **Attached and**
18 **labeled Exhibit "A"** is a copy of the very Dildo RESPONDENT slapped me in the face with on
19 4/21/2007 which was the very item he used to rape me with back in 2004! On the outside
20 RESPONDENT looks and acts like he is a decent man however he actually is a perverted individual
21 that I want no part of. Throwing his dildo at me just takes the cake and Im done with this!

22 On 4/21/2007 RESPONDENT also walked around my home and commenced to going
23 through my personal things and property. I didn't want to upset him so I said nothing.
24 RESPONDENT got on my computer and made copies of my files and put them on his portable
25 thumb drive and then erased allot of my files and documents I had labeled divorce evidence, and
26 things I saved for several years! When I asked RESPONDENT to stop he got up, and went to the
27 kitchen and got a knife from the counter and whispered " remember what I said i would do" Then
28 he said "just kidding" and put the knife down.


1 Then RESPONDENT stated " *Carla you midas well just walk away from everything*
2 *because GEORGE HALVERSON (President of Keiser) went through 2 divorces and knows just*
3 *what to do and is the one helping me on my divorce case. You wont get anything from the quadro*
4 *and I'm going to have Audrey make you move out of this house so that the courts will order the kids*
5 *to come live with me since you wont be here much longer. You see they cant make me change the*
6 *schools so I will have to have the kids. Think about it Carla... You cant stay afloat much longer and*
7 *it will only get worse, so I suggest you just walk away from it all... I run KEISER. Do you think they*
8 *really will do anything against me...?* RESPONDENT then said if i piss him off he will see to it
9 errors occur again on the wage assignment check and delay me in getting payment.

10 RESPONDENT then walked though my house, looked through the refrigerator, pantry and
11 even my closets and took **documents**. Respondent also regularly comes by my home and goes
12 through my mailbox and removes mail and returns certain mail back to me opened. RESPONDENT
13 calls business and mutual friends and defames me. On 2 occasions RESPONDENT entered my home
14 while i slept using his garage remote to gain entry and removed things. The last conversations where
15 RESPONDENT threatened to kill me and made other vile comments I recorded to have proof. I will
16 bring it to court so the courts can hear just how RESPONDENT actually is! I was informed I need
17 a stipulation by RESPONDENT to use my recordings so I will ask RESPONDENT'S attorney for
18 a stipulation and then the courts will no first hand what sort of person RESPONDENT actually is!

19 I'm simply not taking any more crap from RESPONDENT and tired of his threats and overall
20 behavior despite the fear I have. RESPONDENT has not done anything directly to the children so
21 I do not object to the visitation order, however the game where RESPONDENT uses the children
22 to get me on the phone & says to me nasty things and then hangs up on me is over. I need a 5 year
23 restraining order to end RESPONDENT'S game playing and threats.

24 In the meantime, I promise the courts I will do everything to have this case resolved by
25 stipulation very shortly as RESPONDENT'S counsel will be served him a proposed settlement offer
26 im working on as we speak. There are many more instances of abuse to be furnished upon request.

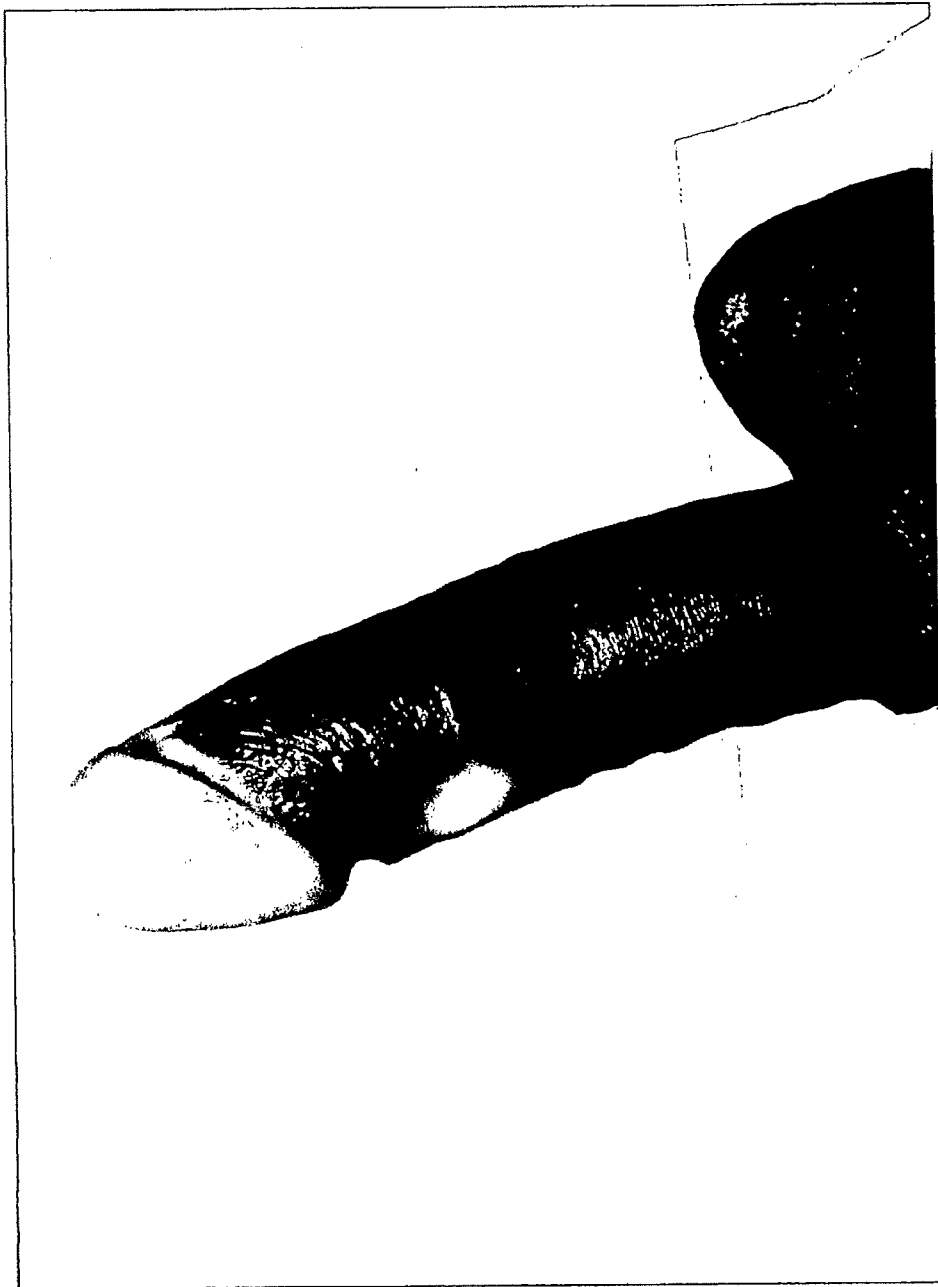
