To Whom This May Concern:

This a personal appeal, also in behalf of many others, in regards to the Planning Department's denial of application for the Green Cross to operate a medical cannabis dispensary at 2701 Leavenworth Street. I feel it was an unjust decision on the part of the Planning Department. The case was the last heard of the day, the neighborhood opposition was given the time to voice their opinions first, but Green Cross supporters were not given any time to voice their opinions. A similar feeling to the recount that got away back in 2000. Or the way it's done in Orange County. It just ires me how the neighborhood coalition groups continue to oppose the opening of a medical cannabis dispensary, such as The Green Cross. Especially, here, in San Francisco.

My personal feeling is that we really need to change people's perceptions of cannabis. And that should start right now, right here in San Francisco, a City supposedly always ahead of the rest of our country in our beliefs. Instead of fueling the negativity of cannabis being viewed as an illegal recreational substance, we need to realize the medicinal physical benefits to suffering patients. Cannabis has been used for centuries by societies far ahead of our own in some ways.

Cannabis really needs to be seen for its' attributes; for the positive. The benefits it medically provides to patients suffering from conditions due to severe or terminal illnesses.
