GLEN COVE is a sacred gathering place and burial ground, utilized by numerous Native American tribes since at least 1,500 BC. The Greater Vallejo Recreation District (GVRD) and the City of Vallejo have for years been pushing forward a proposal to develop this site into a public park, reconfiguring the land and adding paved trails, bathrooms, and a parking lot. All along, the voice of Native people has been loud and clear in regards to this spiritually significant place: NO DEVELOPMENT.

THIS IS A CRITICAL TIME for action, as GVRD has announced their intention to begin the planned desecration. An injunction is being sought by Native groups, but there are currently **no legal mechanisms** in place to stop them. If GVRD brings in bulldozers, a physical occupation of the land may become necessary.

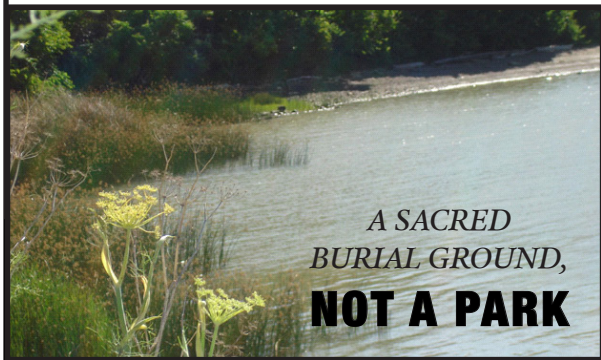
