The **Measure K Oversight Committee** was created by ordinance in 2006 to oversee the implementation of the "Lowest Law Enforcement Policy" (Santa Cruz Municipal Code Chapter 9.84), which makes investigations, citations, arrests, property seizures, and prosecutions for adult marijuana offenses on private property the lowest law enforcement priority for the City of Santa Cruz.

The Committee meets semi-annually to review marijuana citation information, to receive any grievances from individuals who believe they were subjected to law enforcement activity contrary to the Lowest Law Enforcement Priority Policy, and to submit a written report to the City Council.
