Dear Ms. Everling,

Thank you very much for your decision on 14 February 2022 concerning the pleading I had submitted the day before re: "NDU and Post 2009 Honduran Coup Detritus & Ann E. Rondeau, et. al."

As you may know, earlier today the former President of Honduras, Juan Orlando Hernández, agreed to surrender to US authorities a day after they issued an extradition warrant for him. As you will recall from my 14 February pleading and well as from major media breaking news, Hernández was vociferously supported by senior U.S. military officials out of step with other U.S. authorities in the Departments of State and Justice, and in particular with Drug Enforcement Administration (DEA) leadership.

According to a *Wall Street Journal* article published tonight, federal prosecutors allege that Hernández "took bribes to protect drug traffickers who shipped tons of cocaine to the U.S." A *New York Times* article also published in the last few hours said that the US request for his extradition was due to his connection to a "violent drug-trafficking conspiracy." It was only last month that Hernández left office, having eight years as the Honduras chief executive.

I respectfully ask that the following articles and documents be admitted to the Record, as they obviously were not available when the case was closed.

- 1) *The Times* and *WSJ* articles of today, as well as several other analyses conducted by the major media, on the arrest of Hernández, details of the case against him, and the identification of the former president's supporters and protectors inside the U.S. military establishment.

"The appellant is again reminded that, if he has new or additional evidence or argument that he wishes to submit, he may submit a motion for leave, i.e., a request for permission, to submit an additional pleading. Such a motion should briefly identify the additional evidence or argument that he wishes to submit and briefly describe the nature of and need for the additional evidence or argument to his case."


- 2) *The Intercept* article, “Fearing Corruption Charges, Honduran Defense Minister Requests Asylum from Biden,” dated 31 January 2022 and written by investigative reporter Ken Klippenstein. The article quotes me in the context of 2009 coup events and cites a previous *Intercept* article published four years ago in which my disclosures were ratified and expanded upon by a number of sources, including key figures in the U.S. intelligence community.
- 3) Finally, I ask that unclassified interpretations offered by those who have read my three Congressional Disclosures to the Intelligence Community Office of Inspector General concerning the NDU coup mongers also be included in the Record. I am currently seeking additional readership of the disclosures by Members of Congress and hope to have news about the public availability of their analyses soon.

The documentation listed above helps show how, despite General Colin Powell’s promise in Lima, Peru on September 11, 2001, that the United States would never again support a military coup against an elected government in the Western Hemisphere, the crash and burn of the narco-regime in Honduras shows how the betrayal of that promise at the NDU and elsewhere in the Pentagon severely damaged the rule of law in Central America, and American values, security and prestige both here and abroad.

The continued impunity enjoyed by Vice Admiral Ann E. Rondeau; her sidekick, former National Security Council adviser and still NDU professor Craig Deare (a vehement defender of Mexican General and accused drug cartel associate Salvador Cienfuegos Zepeda), and others who are the focus of my disclosures is a motivating factor in my efforts to bring into account those who, through their actions and/or failure to act, are complicit in crimes against humanity and other “conduct unbecoming.” For that reason, I am now also reaching out to the new elected government of Honduras to serve as an expert witness, such as I did for the Italian government in their case against Chilean dictator and international terrorist kingpin General Augusto Pinochet, in any further judicial proceeding in that country.

Ms. Everling, please enter this pleading into the case Record as an addendum to that which I filed on 13 February and about which you sent a Letter Acknowledging Motion yesterday. I also request that, in making a decision on the “asks” made here today, the MSPB issue specific judgment on each one.
